#### I. AMERICAN SAMOA DEPARTMENT OF EDUCATION (ASDOE)

#### A. MISSION

It is the mission of the American Samoa Department of Education (ASDOE) to provide highly effective educators, appropriate resources and promote community partnerships to ensure meaningful learning opportunities for all children.

#### B. GOVERNANCE:

The ASDOE Teacher Certification Program (TCP) was established pursuant to Public Law (PL) No. 20-30, American Samoa Annotated Code. All policies and regulations governing the TCP are derived from this law and are the responsibility of the ASDOE Director of Education through a designated department office.

As enacted by the Legislature of American Samoa: Section 1.16.1001, is amended to read as follow: The Governor shall appoint a three-member Certification Board subject to confirmation by the Legislature which shall oversee the licensing and certification of all teaching personnel within the public school system. The Certification Board is responsible for enforcing the teacher certification program adopted by the Department of Education and set forth in regulations promulgated by the Director of Education as authorized by this title. The Director shall set forth no later than 30 days from the date of this act, the Teacher Certification Regulations to be adopted in accordance with the Administrative Procedure Act.

#### C. THE GOAL OF THE ASDOE TEACHER CERTIFICATION PROGRAM:

It is the goal of the ASDOE Teacher Certification program that every classroom teacher will achieve the status of being "highly qualified". A highly qualified teacher is defined as one who:

- 1. Has been awarded a bachelor degree by an accredited institute of higher education and has completed required certification courses.
- 2. Has completed a Student Teaching Practicum course offered through an accredited, ASDOE approved institution of higher learning (Applicable to all teachers hired after 2012).
- 3. Has demonstrated proficiency in content knowledge by passing an ASDOE adopted teacher certification exam; and,
- 4. Is certified by the ASDOE Teacher Certification Board at a Professional Teacher Certificate (PTC I) level of higher.

#### D. GOVERNING POLICIES

- 1. All teachers shall be in possession of a current teaching certificate issued by the ASDOE and approved by the Teacher Certification Board prior to assuming any classroom instructional responsibilities.
- 2. A valid teaching certificate (issued and approved by the Teacher Certification Board) and a current teacher performance evaluation for every classroom teacher shall be provided to

the American Samoa Government department of Human Resources to be used for annual increment consideration.

- 3. All newly hired (after August 2012) teachers shall complete the ASDOE Induction/Orientation Program prior to beginning classroom instructional responsibilities.
- 4. Unless otherwise stated, the ASDOE/Teacher Quality Office shall create and maintain complete and up to date professional profile records of all teachers. These records must include, but not be limited to, official academic credentials (transcripts and degrees) from an accredited Institution of Higher Education (IHE) and evidence of having successfully completed specified proof proficiency exams.
- 5. The ASDOE shall adhere to guidelines established by the United States Department of Education (ASDOE) by recognizing only seven (7) Regional accrediting agencies for institutions of higher learning and seven (7) National accrediting agencies for degrees and licensing/certification earned
- 6. Effective August 2020, the ASDOE shall assess fees for the issuance of misplaced and/or lost teacher certificates. (PL No. 20-30, Section 16. 1003).
- 7. To promote achievement of the status of being highly qualified, effective August, 2016, all who seek employment as a classroom teacher must meet these minimum requirements:
  - a. Have earned at least an Associate of Arts degree in Education;
  - b. Have successfully completed Praxis I-Core exams:
  - c. Have completed all ASDOE Certification coursework.
  - d. Have graduated with a Grade Point Average (GPA) of 2.75 or higher in all Associate and Bachelor degree core content area coursework (ELA, Math, Science, Social Studies and Samoan Studies).
- 8. The process of reclassifying teachers shall be initiated by a recommendation from the Teacher Quality Office and finalized by the Director of Education.

### II. TEACHER CERTIFICATION CATEGORIES AND REQUIREMENTS

The ASDOE teacher certification process adheres to the legal mandates by certifying all teachers in one of three categories. They are:

#### A. TEMPORARY TEACHING CERTIFICATE

- 1. Duration Period: Three years, REVIEWED on an individual basis with a limit of one 1 year extension. This level of certification is issued to:
  - a. All teachers who have a high school diploma and/or tradesman license and five years of teaching experience (hired prior to August 2010).
  - b. All teachers who have earned an Associate degree but are not enrolled in an institutionally accredited Bachelor degree program (hired prior to August 2013).
  - c. All teachers who are hired on a short-term contract or voluntary basis (hired after August 2012).
- 2. Extension of Certificate: Shall be granted no more than once. Extension will be for one year.

#### 3. Non Compliance Action:

- a. If, after one renewal at the Temporary level, there is no evidence of having completed certification requirements or enrollment in a Bachelor degree program, a recommendation for termination may be submitted.
- b. If, after two years at the Temporary level, there is evidence of an effort to fulfill certification requirements, the decision to extend the Temporary level of Certification will be determined by the Certification Board; or a recommendation for termination may be submitted to the Director of Education.

#### B. PROVISIONAL TEACHING CERTIFICATE

- 1. Duration Period: Three years with one renewal allowed, pending successful completion of a Bachelor degree and Praxis I/Core proficiency exams. This level of certification issued to:
  - a. Teachers who are enrolled in and will complete a Master degree and certification coursework within the certification period.
  - b. Teachers who have earned a Bachelor degree in a HTF content area and successfully completion of Praxis I/Core proficiency exams.
  - c. Teachers who have earned a Bachelor degree, but who have not completed required certification coursework and Praxis I/Core proficiency exams.

- 2. Duration Period: Two years with one renewal allowed for successful completion of a Masters and/or Doctorate degree and Praxis I/Core proficiency exams. This level of certification issued to:
  - a. Teachers who earned a Master degree but who have not completed required certification coursework and Praxis I/Core proficiency exams.
  - b. Teachers who have earned a Doctorate degree but who have not yet completed required certification coursework or Praxis I/Core exam.
- 3. Extension of Certificate: Granted upon completion of all recertification requirements. Extension will be for one year.

#### 4. Non Compliance Action

a. If, at the end of the second or third year of a provisional level of certification, there is no evidence of completion nor evidence of an effort to certification requirements, the decision to either extend the Provisional level of certification will be determined by the Certification Board; or a recommendation for termination may be determined by the Director of Education.

#### C. PROFESSIONAL TEACHING CERTIFICATE (PTC)

There are six levels of Professional Teaching Certificates. They are:

- 1. PTC I Duration Period: Five years. This level of certification is issued to:
  - a. Teachers who have earned a Bachelor of Arts (BA) or Bachelor of Science (BS) degree with successful completion of Praxis I/Core exams and all Certification coursework; or
  - b. Teachers who have earned a Bachelor in Education (B.Ed.) degree with successful completion of Praxis I/Core exam.
  - c. Recommendation: Required Certification & continuing education coursework completion of Master's degree
- 2. PTC II Duration Period: Five years. This level of certification is issued to:
  - a. Teachers who have earned a BA or BS degree and successfully completed the Praxis I/Core exam, all Certification coursework; and Praxis II exams or
  - b. Teachers who have earned a B.Ed. with Certification coursework and passed Praxis I/Core and Praxis II exams.
  - c. Recommendation: Required Certification & continuing education course work completion of Master's degree

- 3. PTC III Duration Period: Five years. This level of certification is issued to:
  - a. Teachers who have earned an M.Ed. and have successfully completed the Praxis I/Core proficiency exams and all Certification coursework; or
  - b. Teachers who have earned a MA or MS who have successfully completed all Certification coursework, and Praxis I/Core exams.
  - d. Recommendation: Required Certification and continuing education coursework; Pass Praxis II or NOCTI for CTE teachers
- 4. PTC IV Duration Period: Five years. This level of certification is issued to:
  - a. Teachers who have completed all requirements for the PTC III level of certification (MA/MS/M.Ed., Praxis 1/core & Certification Coursework); and, have successfully completed and Praxis II exams or NOCTI for CTE teachers.
  - b. Recommendation: 80 hours of documented participation and/or presentation or professional development training. Relevant content area continuing Education coursework
- 5. PTC V Duration Period: Five years. This level of certification is issued to:
  - a. Teachers who have earned a Doctorate Degree (Ph.D. or Ed.D.), have successfully completed Praxis I/Core and Certification Coursework.
  - c. Recommendation: 80 hours of documented participation and/or presentation or professional development training. Relevant content area continuing Education coursework
- 6. PTC VI Duration Period: Eight years. This level of certification is issued to:
  - a. Teachers who have completed all requirements for the PTC V level of certification (Ph.D./Ed.D., Praxis 1/core, & certification coursework); and, have successfully completed Praxis II exams or NOCTI for CTE teachers.
  - b. Recommendation: 80 hours of documented participation and/or presentation or professional development training. Relevant content area continuing Education coursework
- Renewal of Professional Certificates shall be granted at the expiration
  of every certificate for as long as the individual holds the title of
  Teacher in the American Samoa Department of Education. Renewals
  will be granted for the same amount of time as the duration of each
  specific Professional Certificate.

# D. SPECIALIZED AREAS OF CERTIFICATION:

In addition to meeting general certification requirements, Early Childhood Education, Special Education and Vocational Education teachers must complete specialized coursework in their respective areas. Refer to Appendix III.

- 1. ECE
- 2. Special Education
- 3. Vocational Education

#### III. DEGREE REQUIREMENTS

To ensure degree programs meet acceptable levels of quality and address the professional expectations of the classroom teachers, the following criteria has been adopted by the American Samoa Department of Education:

#### A. ACCREDITATION OF DEGREES

- 1. All degrees must have institutional accreditation from an IHE that is accredited by one of seven Regional or seven National accrediting agencies that are recognized by the USDOE and endorsed by the ASDOE (See Appendix IV).
- 2. Coursework and credit hours of degree programs shall adhere to the following ASDOE criteria:
  - a. Enrollment in online and traditional degree programs for inservice shall be limited to two courses per ASDOE academic semester.
  - b. All Bachelor in Education (online and traditional) degree programs must include a student teaching practicum course.

#### **B. EVALUATION OF DEGREES**

- 1. All degrees not earned from an American IHE are to be evaluated prior to employment to determine the US degree equivalency. Educational Credential Evaluators (<a href="www.ece.org">www.ece.org</a>) is the only agency recognized by the ASDOE to perform this required degree evaluation. All financial responsibilities lie solely to the applicant.
- 2. Evaluation of coursework offered by University of Hawaii and American Samoa Community College IHE will be performed by the ASDOE to determine the level of completion of certification course requirements.

#### IV. TEACHER CERTIFICATION TEST REQUIREMENTS

Passing a standardized test is a basic requirement for teacher certification. These tests attempt to measure a teacher's knowledge and skills, and are used to ensure educators have acquired the basic content skills required to teach.

#### A. CERTIFICATION TESTS ADOPTED BY THE ASDOE

- 1. Successful completion of the Praxis I/Core and Praxis II exams, adopted by the ASDOE and administered by the Education Testing Service (ETS), are required to determine proficiency in a content area.
- 2. Any and all test-taking financial obligations are the responsibility of the individual.

#### B. SUCCESSFUL COMPLETION REQUIREMENTS

1. Praxis I:	Reading	170
	Writing	170
	Mathematics	170
2. Praxis Core:	Reading	156
	Writing	162

3. New cut off score approved by ASDOE based on the following:

- Recommended Passing scores by ETS expert panel after a new study conducted in October 2021. This new cut off score is for those who need substantial academic support to succeed in an educator preparation program (EPP).
- Adopted from the ETS recommended passing scale score for those who need substantial academic support (especially for ESL Teachers) and approved by ASDOE on March 13, 2024, are as follows:

Praxis Core:	Reading	142
	Writing	144
	Mathematics	134

- 4. The ASDOE has adopted specific Praxis II exams to be used to determine proficiency in a content area. Because passing criteria scores vary from one test to another, please refer to the ETS's website (www.ets.org) for the passing criteria of a specific exam.
- 5. All teacher applicants must successfully complete all three subject area tests of the Praxis I/Core exam within one year of being hired.
- 6. Praxis I/Core scores do not require renewal unless a newly hired teacher received scores more than ten years prior to employment within the ASDOE; however, Praxis II scores are valid for a period of ten years.

#### V. THE CERTIFICATION PROCESS

Educational research and scholarly articles clearly support the belief that teacher performance is directly linked to student achievement; the better prepared and effective the teacher is, the more likely student achievement will occur in and out of the classroom. Essentially, the teacher is the primary factor that impacts student learning and achievement.

Consequently, the ASDOE subscribes to this thinking and is committed to raising the bar by providing a pathway to success for all teachers and by ensuring all teachers receive the professional recognition they deserve through certification.

Through the certification process, every effort will be made to provide valid information, guidance and support services to teachers as they pursue their professional goals.

#### A. POLICIES

- 1. Teachers who are not pursuing an advanced degree will be required to enroll/engage in continuing educational courses.
- 2. Teachers must provide proof of completion of required continuing education, regardless of their assigned level of certification, immediately upon completion of coursework.

- 3. Valid and current stateside teaching licenses/certificates will be reviewed on an individual basis by the ASDOE to determine applicability to the requirements of the ASDOE certification process.
- 4. The validation of the certification records shall be the sole responsibility of the ASDOE, Teacher Quality Office (TQO).
- 5. All core content area certification levels 100-200 coursework shall be completed with an academic grade of C or better; all core content area certification levels 300 or higher shall be completed with an academic grade of B or better.

#### **B. PROCEDURES**

The process leading to the accurate identification and assignment of a teacher's level of certification is:

- 1. A thorough review and evaluation of all academic degrees and transcripts;
- 2. The demonstration of basic content area proficiency by successful completion of the Praxis I/Core and specific content area proficiency by successful completion of an ASDOE adopted Praxis II exams;
- 3. Documentation of having completed all required certification coursework;
- 4. Documentation of having completed continuing education for recertification purposes; and,
- 5. Evaluation by Educational Credential Evaluators (ECE) of foreign degrees, if applicable.
- 6. Recommendation by Teacher Quality and approval by Teacher Certification Board.

#### VI. TEACHER RECLASSIFICATION

The purpose of the teacher reclassification is to provide a comprehensive classification structure for teachers while also providing a salary scale compatible with the revised standards.

#### A. CLASSIFICATION TITLES AND QUALIFICATIONS

- 1. Associate Degree
  - a. Teacher Aid III:
    - i. Minimum qualifications of a high school diploma or general education degree;
    - ii. Duration period of two years with a one-year extension
  - b. Teacher V:
    - i. Certified in a content or specialized area such as ECE, SPED, CTE;
    - ii. Duration period of three years with a one-year extension
  - c. Teacher VI:
    - i. Holds an AA/AS degree;
    - ii. Duration period of three years with a one-year extension
- 2. Bachelor Degree
  - a. Teacher VII:
    - i. Holds a BA/BS
    - ii. Duration period of three years with a one-year extension
  - b. Teacher VII-1:
    - i. Holds a BA/BS with ASDOE certification coursework or holds a B.Ed.;
    - ii. Duration period of three years with a one-year extension
  - c. Teacher VII-2:
    - i. Holds a B.Ed., or BA/BS in a specialized or hard to fill content area;
    - ii. Duration period of three years with a one-year extension
  - d. Teacher IX:
    - i. Holds a BA/BS/B.Ed., complete ASDOE certification coursework, and Praxis I/Core;
    - ii. Duration period of five years
  - e. Teacher IX-1:

- i. Holds a B.Ed./BA/BS, complete ASDOE certification coursework, Praxis I/Core and Praxis II;
- ii. Duration period of five years

#### 3. Master Degree

- a. Teacher X:
  - i. Holds a MA/MS degree;
  - ii. Duration period of two years with a one-year extension
- b. Teacher X-1:
  - i. Holds a MEd/MA/MS, complete ASDOE certification coursework;
  - ii. Duration period of two years with a one-year extension
- c. Teacher X-2:
  - i. Holds a MEd/MA/MS in a specialized or hard to fill content area, pass Praxis II or NOCTI
  - ii. Duration period of two years with one-year extension
- d. Teacher XII:
  - i. Holds a MA/MS/MEd complete ASDOE certification coursework, pass Praxis I/Core and Praxis II;
  - ii. Duration period of five years
- e. Teacher XII-1:
  - i. Holds a MA/MS/MEd complete ASDOE certification coursework, pass praxis I/Core, Praxis II or NOCTI;
  - ii. Duration period of five years

### 4. PhD. Degree

- a. Teacher XIII:
  - i. Holds a Ph.D. degree;
  - ii. Duration period of two years
- b. Teacher XIII-1:
  - i. Holds a Ed.D. Degree;
  - ii. Duration Period of two years
- c. Teacher XIII-2:
  - i. Holds a Ph.D./Ed.D., complete ASDOE certification coursework, pass Praxis I/Core;
  - ii. Duration period of five years
- d. Teacher XIII-3:

- i. Holds a Ph.D./Ed.D., complete ASDOE certification coursework, pass Praxis I/Core, Praxis II or NOCTI for CTE teachers.
- ii. Duration period of eight years

#### B. PROCESS FOR RECLASSIFICATION

The change of a teacher's classification indicates his/her advancement through the classification scale and is reflected by and adjustment in salary.

- 1. The recommendation for reclassification is initiated by the ASDOE Teacher Quality Office and is a reflective of academic achievements and/or successful completion of content proficiency exams.
- 2. The Certification Program Director initiates the Reclassification process once the appropriate documents are submitted. The TQO Assistant Director oversees and confirms the reclassification of all teachers.
- 3. It is sole the responsibility of all teachers to submit the following documents to the ASDOE Teacher Quality Office to initiate the reclassification process:
  - a. Once a degree from a Higher Institute of Learning is awarded, the teacher submits a copy to the ASDOE Teacher Quality Office.
  - b. An official transcript must accompany the copy of awarded degree.
  - c. A current copy of ASG 303 from the Department of Human Resource must be submitted.
- 4. Once the reclassification forms are completed, signed, and approved by the TOO Assistant Director:
  - a. Copies are filed for TQO documentation;
  - b. Originals are submitted to the ASDOE Personnel Office;
  - c. All reclassification submissions must be approved by the ASDOE Director.
  - d. The ASDOE Personnel Office submit the documents to the ASG Department of Human Resource for adjustment in salary.
- 5. The reclassification process takes approximately 10 working days to complete once it leaves the ASDOE Personnel Office.

#### VII. DISCPLINARY ACTION

It is expected that teachers will honor and abide by the Professional Code of Ethics for Educators while they are in the employment of the American Samoa Department of Education. In the event that character, performance, attendance or any other factor of misconduct warrants disciplinary action, the ASDOE will comply with the provisions of relevant workplace agreements and the Department of Human Resource (DHR) regulations when managing disciplinary actions of teaching personnel.

#### A. SUSPENSION:

The following are examples of conduct that may warrant suspension for a minimum of three days without pay:

- 1. Three documented acts of insubordination.
- 2. Documented misuse and/or abuse of school property or its resources.
- 3. Mishandling of school-raised funds.
- 4. Three documented reprimands.

#### B. REVOCATION OF CERTIFICATION:

The following are examples of conduct that may warrant revocation of a certificate or license and removal from a classroom assignment:

- 1. Two consecutive years of unsatisfactory performance evaluations;
- 2. Knowingly provide false information on an application for certification;
- 3. Failure to meet all of the requirements of the teaching profession;
- 4. Willful violation of the Code of Ethics of the American Samoa Teaching Profession.
- 5. Conviction, finding guilt of, withholding judgement or suspended sentence for felony offenses against children;
- 6. Conviction, finding guilt of, withholding judgement or suspended sentence for dealing, selling, trafficking, or consumption of controlled substances as defined in the American Samoa code;
- 7. Abandonment of position.

#### APPENDIX I PROFESSIONAL CODE OF ETHICS FOR TEACHERS

(Adapted from the NEA Professional Code of Ethics for Teachers)

#### **PREAMBLE**

The American Samoa Department of Education believes that the education profession consists of one education workforce serving the needs of all students and that the term 'educator' includes education support professionals.

The educator, believing in the worth and dignity of each human being, recognizes the supreme importance of the pursuit of truth, devotion to excellence, and the nurture of the democratic principles. Essential to these goals is the protection of freedom to learn and to teach and the guarantee of equal educational opportunity for all. The educator accepts the responsibility to adhere to the highest ethical standards.

The educator recognizes the magnitude of the responsibility inherent in the teaching process. The desire for the respect and confidence of one's colleagues, of students, of parents, and of the members of the community provides the incentive to attain and maintain the highest possible degree of ethical conduct. The Code of Ethics of the Education Profession indicates the inspiration of all educators and provide standards by which to judge conduct.

The remedies specified by the ASDOE and/or its affiliates for the violation of any provision of the Code shall be exclusive and no such provision shall be enforceable in any form other than the one specifically designated by the ASDOE.

#### PRINCIPLE I: COMMITMENT TO THE STUDENT

The educator strives to help each student realize his or her potential as a worthy and effective member of society. The educator therefore works to stimulate the spirit of inquiry, the acquisition of knowledge and understanding, and the thoughtful formulation of worthy goals.

In fulfilling of the obligation to the student, the educator:

- 1. Shall not unreasonably restrain the student from independent action in the pursuit of learning.
- 2. Shall not unreasonably deny the student's access to varying points of view.
- 3. Shall not deliberately suppress or distort subject matter relevant to the student's progress.
- 4. Shall make reasonable effort to protect the student from conditions harmful to learning or to health and safety.
- 5. Shall not intentionally expose the student to embarrassment disparagement.

- 6. Shall not on the basis of race, color, creed, sex, national origin, marital status, political or religious belief, family, social or cultural background, or sexual orientation, unfairly:
  - a. Exclude any student from participation in any program;
  - b. Deny benefits to any student;
  - c. Grant any advantage to any student;
  - d. Use professional relationships with students for private advantage; or,
  - e. Disclose information about student obtained in the course of professional service unless disclosures serves a compelling professional purpose or is required by law.

#### PRINCIPLE II: COMMITMENT TO THE PROFESSION

The education profession is vested by the public with a trust and responsibility requiring the highest ideals of professional services.

In the belief that the quality of the services of the education profession directly influences the nation and its citizens, the educator shall exert every effort to raise professional standards, to promote a climate the encourages the exercise of professional judgement, to achieve conditions that attract person worthy of the trust to careers in education, and to assist in preventing the practice of the profession by unqualified persons.

In fulfilling of the obligation to the profession, the educator:

- 1. Shall not in an application for a professional position deliberately make a false statement or fail to disclose a material fact related to competency and qualification;
- 2. Shall not misrepresent his/her professional qualifications;
- 3. Shall not assist any entry into the profession of a person known to be unqualified in respect to character, education, or relevant attribute;
- 4. Shall not knowingly make a false statement concerning the qualifications of a candidate for a professional position;
- 5. Shall not assist a non-education in the authorized practice of teaching;
- 6. Shall not disclose information about colleagues obtained in the course of professional service unless disclosure serves a compelling professional purpose or is required by law;
- 7. Shall not knowingly make false or malicious statements about a colleague;
- 8. Shall not accept any gratuity, gift, or favor that might impair or appear to influence professional decisions or action.

(Adopted by the NEA 1975 Representative Assembly)

#### APPENDIX II GLOSSARY

This glossary provides an explanation and/or description of terminology used by the American Samoa Department of Education (ASDOE) to clarify elements pertaining to teacher certification and classification.

- 1. Certification Levels: The three categories mandate by local law (PL 20-30) by which all teachers of ASDOE shall be certified and receive authorization to provide classroom instruction. These levels are: Temporary, Provisional, and Professional I-VI.
- 2. Hard to Fill Content Area: Academic content areas of Math, Science, English, Samoan and Social Studies where a shortage of teachers occurs annually.
- 3. Certification and Continuing Education Coursework Requirements: A matrix listing required certification and continuing education courses for teachers as they pursue certification and professional growth.
- 4. Teacher Reclassification: The change of a teacher's classification indicates hi/her advancement through the classification scale and is reflected by an adjustment in salary. The recommendation for reclassification is initiated by the ASDOE Teacher Quality Office and is reflective of academic achievements and/or successful completion of content proficiency exams.
- 5. Teacher Recertification: Upon completion of the stated requirements, the recertifying teachers occurs every two years for the Temporary certificate holder, every five years for the Provisional certificate holder, every five years for the Professional certificate I-V holder, and every eight years for the Professional VI certificate holder. A change in the level of certification renewal is dependent upon the completion of all renewal requirements established by the ASDOE.
- 6. Tests of Proficiency Exams: Effective SY 2014-2015, the ASDOE adopted both Praxis I Series and Praxis II exams to determine one's level of proficiency in a content area, a requirement of the Professional Levels of certification. The exams adopted by the ASDOE and administered through the Educational Testing Services (ETS) are:
  - a. Praxis I Series Exam: A series of tests in Reading (170), Writing (170), and Math (170) which are used to determine a teacher's basic levels of competency in these content areas.
  - b. Praxis II Exam: The ASDOE has identified and adopted specific Praxis II content area exams to determine proficiency in specific content areas. Passing. criteria vary from one exam to another.
  - c. Praxis I/Core Academic Skills for Educators: In September 2014, alignment of the Praxis I exam with the Common Core Standards was completed and renamed CORE, commonly referred to as Praxis I/Core exam. While the format of the exam remains the same, the passing scores are as follows-Reading (156), Writing (162), and Math (150).

- 7. Certification Course Requirements: A list of education courses required at specific levels of certification. A thorough review of completed coursework may determine equivalency to the coursework required for certification.
- 8. Teacher Performance Evaluation: A teacher evaluation system conducted biannually and includes four weighted components-Classroom Observation (50%), Student Work Samples (20%), Teacher Professional Portfolio (20%), and Teacher Attendance (10%). Data derived from these evaluations is gathered and analyzed to drive decision-making with the goal of improving student achievement.

# APPENDIX IV ASDOE TEACHER CERTIFICATION REQUIREMENTS

All teachers (newly hired or existing) shall complete the following certification requirements. within the allocated certification period in addition to the ASDOE Teacher Induction Program organized by the Teacher Quality Office.

#### I. Certification Courses Requirements.

- UH ITE 360/ASCC ED 280 (Multicultural Education/Introduction to Bilingual Education).
- UH ITE 403/UHED 310/ASCC ED300 (Seminar in Educational Inquiry or Education in American Society/Foundations of Education)
- UH ITE 380/UHED 311/ASCC ED301 (Managing Classrooms or Psychological Foundations of Education/Introduction to Educational Psychology).

#### II. Proficiency Examination Requirements.

All teachers (newly hired or existing) shall complete the Praxis 1/Core proficiency examination as a requirement within the allocated certification period.

#### III. Exemption.

**Grandfather Clause:** Teachers hired by ASDOE on or before 2002 and are still continuing with the American Samoa Public school system without any interruption in their service are exempted from the following

- all certification coursework.
- the Praxis 1/core proficiency examination

The exempted teachers shall complete a minimum of 10 to 20 professional development workshops, ASDOE training, and/or off-Island workshops towards professional growth.

This exemption is to re-issue the existing teaching certificate issued by the ASDOE and approved by the Teacher Certification Board.

These exempted teachers are not eligible for the following:

- reclassification and pay adjustments.
- the ASDOE-sponsored Bachelor or Master's program eligibility criteria.
- the TTOY program eligibility criteria.

#### IV. Other Recommendations

Teachers holding Bachelor degrees or higher shall complete the Praxis II subject test or NOCTI for CTE or complete a minimum of two content specified refresher courses organized and conducted by the Teacher Quality Office for content certification.

#### V. Course Descriptions:

- EDEF 310: Foundations of Education: *Interrelated historical, philosophical, and sociocultural contexts of education with an emphasis on identifying, analyzing, and deliberating on contemporary ethical issues, problems, and applications. Students enrolled in colleges other than the College of Education are asked to confer with the College of Education director of student services before enrolling in 310. A-F only.*
- EDEP 311: Introduction to Educational Psychology: *Psychology applied to education, including cognitive, sociocultural, and multicultural approaches to teaching, learning, development, and research. Develops knowledge and written communication skills through an introduction to classroom, assessment, instruction, motivation, classroom management, and standardized testing. A-F only.*
- ITE 360 Multicultural Perspectives in Education: Concepts and methods to develop sensitivity and awareness of cultural influences on behaviors related to schooling. Examines intersections of Native Hawaiian culture with Asian and/or Pacific Islanders fostering multicultural respect and understanding through cross-cultural analysis. A-F only.
- ITE 403 (Alpha) Seminar in Educational Inquiry: Study and discussion of general school-related topics and issues, e.g., dimensions of elementary and/or secondary schooling, school governance, curriculum design and development, the student learner, classroom management; (B) service learning; (C) exploratory education; (D) international field study; (E) minor in education. Each alpha is repeatable one time, up to six credits. A-F only.
- ITE 380 Managing Classrooms (3) COURSES: Analysis of the factors that contribute to learning in the classroom and the development of teacher behaviors that promote such learning. A-F only.

#### APPENDIX V IN-SERVICE TRAINING PROGRAMS

In-Service Training Program for teachers is a continuous and lifelong process whereby teachers try to develop their personal and professional qualities and to improve their knowledge, skills, and practice, leading to their empowerment, improvement and the development of their organization and their pupils.

#### I. Teacher Induction Program

The Induction program coaches young and returning teachers on self-reliance through awareness of the social, intellectual, and moral environment and to discover self-potential and confidence. This program trains the teachers to unpack the ASDOE standards and develop lesson plans, classroom management, teaching strategies, assessment and evaluation, and technology integration. All participants shall complete the following requirements during the Teacher Induction Program.

- General Induction program by various divisions
- Specific Induction training program sessions wherein all teachers must complete the following requirements
  - o ten contact hours of Unpacking the ASDOE standards and benchmarks.
  - o ten contact hours of Lesson Planning.
  - o ten contact hours of assessment, grading and record keeping.
  - ten contact hours of Classroom Management and teaching strategies.
  - ten contact hours of technology integration
- Duration:
  - Two-week program before the new school year.
  - Ouarterly PD follow-up

#### II. Tutoring for Praxis Core Proficiency Exam.

The Teacher Quality Office will tutor/prepare the teachers to complete the Praxis Core requirements for the teaching certification processes for each Praxis Core Components:

- Mathematics
- Reading
- Writing
- Duration: 20 contact hours.

#### III. Content-specified refresher courses (Mathematics and Science only):

The content-specific refresher courses will be an alternative program for Praxis II subject tests for science and mathematics content areas. A teacher must complete at least two content-specific refresher courses in the same subject area to qualify them as equivalent to the praxis II subject test.

• Duration: Ten weeks with a minimum of 60 contact hours

#### APPENDIX VII PROFICIENCY EXAMS ADOPTED BY THE ASDOE

The ETS Praxis Series exams are designed to assess subject matter knowledge and other competencies for individuals planning a career in teaching. The ASDOE adopted the Praxis I Series and Praxis II exams to determine a teacher's basic levels of competency, and/or one's level of proficiency in a content area.

- 1. Praxis I: A series of tests which are used to determine a teacher's basic levels of competency in the following content areas:
  - a. Reading: A passing score of 170
  - b. Writing: A passing score of 170
  - c. Mathematics: A passing score of 170
- 2. Praxis I/Core: This exam is referred to the alignment of Praxis I exam with the Common Core Standards. The format of the exam remains the same as Praxis I to determine a teacher's basic levels of competency in the following content areas:
  - a. Reading: A passing score of 156
  - b. Writing: A passing score of 162
  - c. Mathematics: A passing score of 150
- 3. Praxis II: The ASDOE has identified and adopted specific Praxis II content area exams to determine a teacher's level of proficiency in specific content areas. The passing criteria vary from one exam to another (a list of passing scores can be provided upon request).
- 4. National Occupational Competency Testing Institute (NOCTI): The ASDOE identified and adopted the NOCTI exam to measure and validate a teacher's competency level in knowledge, skills and applications in specific technical areas. NOCTI offer the following exams:
  - a. Written Test: The comprehensive test is administered to determine a teacher's level of competency in a specified trade. The passing criteria vary from one exam to another.
  - b. Performance Test: An opportunity for a teacher to demonstrate hands on skills of specific trade by completing the actual job using tools, materials, and equipment of the occupation. The passing criteria in measuring these skills vary from trade to another.
